Dear Cyclist

Please read the terms and conditions of this scheme. You will need to sign this document to demonstrate compliance to the scheme. Bikes are provided to employees of Stockley Park for use to on the Park/country park, either leisurely during lunchtime or to and from meetings. The duration of use will be for a two-hour slot as maximum use time. Extensions can be confirmed on prior requests, but all bikes must be back in the stand by 4.30 on the day of the loan period. The Scheme is not extended to contractors or sub contractors of tenant companies; however, SPECL reserve the right to review as necessary.

Terms and Conditions

1. I understand that I am the only person authorised to use the bike and that it is for the above designated purpose only.
2. I understand that I am responsible for checking that the bike is roadworthy before using it and for reporting any faults before or during use.
3. I declare my health to be of a standard necessary to ride a bicycle.
4. I declare my cycling ability to be of a sufficient standard for riding on the roads in a City Centre environment.
5. I understand that it is my responsibility to ensure my health and safety prior to embarking on this scheme.
6. I will not use the bike in inclement weather conditions.
7. I agree to ride the bike in a safe and responsible manner and make good use of the cycle routes where available on the Park / country park.
8. If I am involved in an accident, or if there is a problem with the bike, I will report it to SPECL immediately on 01895 444 100.

9. If an incident has been experienced as in para 8 above, assistance can be obtained from the Park Security on 020 8561 8701.
10. I will return the bike to the Security Office on completion of my loan period.
11. I will first ensure appropriate checks are carried out before signing the back in with the Park Security.
12. If the bike is stolen or vandalised in any way, I will report it to the Police and to SPECL immediately.
13. I confirm that I have inspected the bike before taking it and inform SPECL of any damages or concerns before commencing the loan period.
14. Riding in mud and bad weather conditions will make the bike dirty, therefore I understand that it is my responsibility to return the bike in the same condition as it was received.
15. The bikes will be checked and maintained quarterly.

Use of this scheme shall be at the Cyclist's own risk. SPECL will not accept responsibility for any consequential loss or damage howsoever arising from the loan of the bike to The Cyclist or any other liability, unless it arises from our negligent act or default.
